## Parenting Plan Worksheet

Please fill out and bring to your next mediation session.

### 1. DESIGNATION OF RESIDENTIAL PARENT

Who will be the primary residential parent (who will the children stay with the greatest percentage of time?)

### 2. DECISION MAKING

Joint or full custody of mother or father? Custody is about decision making, not how much time a parent spends with a child. These decisions revolve around education, religious training, health (medical, dental, vision, and mental health), and extra curricular activities. If you have a great amount of agreement around these major areas, joint custody is normal.

### 3. PARENTING TIME SCHEDULE

The non-residential parent is entitled to have parenting time with the child. What kind of schedule have you spoken about? What kind of schedule do you desire? This is the basic schedule of parenting time. Summer and holidays are below.

Some examples include:

#### 50/50 plans

- Alternating Weeks (one week with one parent, then one week with the other parent)
- Alternating Days within a two week block.

- Alternating Weekends with a weekday overnight (This is a standard default plan by the State of Oregon.)

### **4. FUTURE MOVE OF A PARENT**

Is either parent anticipating a move beyond 30 miles of the current residence? If so, when and how far?

### **5. OTHER CONSIDERATIONS:**

Who will retain health insurance for the children? How much does it cost just to insure the children?

How will children's activities (sports, music, dance, etc.) impact parenting time and expense?

Do you have a college savings plan for the children?

Are there any special considerations, physical or mental health issues, learning disabilities, etc., that may impact time and expense of parents?

If you have teenagers, have you discussed jobs, dating, cars, etc?

Have you discussed how you can CONSISTENTLY parent the children in different homes? In other words, it is extremely helpful to the children if the rules are the same for each household.
